- On behalf of the Director, Central Arid Zone Research Institute, Jodhpur online tenders are invited for Annual Rate Contract for engagement of agency for providing of man power on outsourcing basis for a period of one year depending upon the requirements of the ICAR-Central Arid Zone Research Institut e, Jodhpur-342 003 from time to time as per the terms and conditions set forth in the following paragr aphs. The Services of the manpower agency would be required initially for a period of one year. The c ontract can be extended further subject to satisfactory compliance of terms and conditions of the con tract.
- 2. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened o n the next working day at the same time. The Director, ICAR - CAZRI reserves the right to accept or reje ct any or all the tenders.
- 3. The interested Firms {except those who are registered with the Central Purchase Organization & National Small Industries Corporation (valid proof should be mandatory enclosed)} are req uired to deposit (in original) an Earnest Money Deposit (EMD) of Rs. 1.00 lakh (Rupees one lakh only) in the form of Demand Draft from any of the Commercial Bank in India, in favour of "ICAR Unit CAZRI,

Jodhpur". The bidder must have current Income Tax/ GST/Service Tax and statutory registration(s).

- 4. - 7. Bidders/tenderers shall undertake to the apply with allow statutory provisions are required for such ma n power to be provided including Minimum Wages Act, EPF, ESI, GST, Service Tax etc. as required under law and shall indemnify CAZRI from all libels/suits/litigations etc.
- 8. The Contractual Agency shall take all responsibility and obligation for providing man power engaged by him for the purpose at ICAR CAZRI. ICAR CAZRI will not be responsible for any libels/suits/litigation or otherwise/obligation/commitment/liability to any party(ies) or persons(s) whatsoever.

SECURITY OF CONTRACT: The Contractual Agency shall provide Security in the form of DD/Bank Guar antee/FDR in favour of ICAR Unit, CAZRI, payable at Jodhpur-342 003 for contract period as would be specified in the work order to be awarded to the successful bidder for a 10% of the total value of annual contract and execute an agreement before starting the contract. The decision of the sole Arbitrator so appo inted shall be final and binding on the parties. Arbitration proceedings shall be governed by the Arbi tration & Constitution Act, 1996.
